Dear Sir/Madam,

Pursuant to Regulation 30 and other applicable regulations, if any, of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 and in continuation to letter DEL/SEC/120 dated 12th March, 2018, the Exchange is informed that the Committee of Creditors of the Company, at its meeting held on 1st April, 2018 has, after evaluation of resolution plans received from resolution applicants, rejected the resolution plans received and taken a decision to liquidate the Company.

The exchange is further informed that the Company has already filed an appeal before the Hon'ble National Company Law Appellate Tribunal, New Delhi (NCLAT, New Delhi), against the order dated 6th July, 2017 of the Hon'ble National Company Law Tribunal, Kolkata (NCLT, Kolkata) inter alia ordering commencement of Corporate Insolvency Resolution process against the Company.

The said NCLAT, Delhi, while reserving the judgment has, on 5th March, 2018 ordered that if any order is passed it shall be subject to decision of appeals before NCLAT, New Delhi. A copy of the order dated 5th March, 2018 is enclosed as annexure – A.

The exchange is also informed that NCLT, Kolkata, on 2nd April, 2018, while taking note of the order dated 5th March, 2018 of the NCLAT, Delhi, has fixed the next date of hearing as 11th April, 2018. Further, NCLT, Kolkata has also directed that in the meantime, the present resolution professional will continue to manage the day to day affairs of the Company.
